The Under Secretary (President's Gardens), President's Secretariat, Rashtrapati Bhavan, New Delhi on behalf of the President of India, invites online bids from the eligible bidders for award of contract for supply of Fresh Cut Flower to President's Gardens, President's Secretariat, Rashtrapati Bhavan, New Delhi for a period of one year. Bidders are advised to follow the instructions for online bid submission through Central Public Procurement Portal at: https://www.eprocure.gov.in/eprocure/app. Only online bid will be accepted.

Guidelines for the bidders

- (i) The bids will be accepted only online through https://eprocure.gov.in under two bid systems viz. Technical Bid and Financial Bid. The last date of submission of bids/quotations is 3rd December 2025 before 18.55 hrs Any Bid/Quotation received after due date and time, by whatever means, shall not be entertained. The technical bids will be opened online by the Bid Opening Committee at 04th December, 2025 (Onwards). Bidders can see bid opening online on CPP portal (or they may come to Garden Section of President's Secretariat). Financial bids of only those bidders who qualify on the basis of the technical bids will be opened, notice for opening of which will be issued subsequently. Incomplete or conditional bids/quotations will not be entertained.
- (ii) All details regarding tender are available on President's Secretariat website https://www.Rashtrapatisachivalaya.gov.in and https://www.eprocure.gov.in. Any change/modification in the Tender enquiry will be intimated through above websites only. Bidders may keep themselves updated through same.
- (iii) For submission of E-bids, bidders are required to get themselves registered with eprocure.gov.in website along with Digital Signature Certificates issued by CCA under IT Act-2003.

3. Minimum Eligibility Criteria

(c)

The estimated cost of the tender is Rs. 1.25 crores.

- (i) The firm/company should be registered or enlisted contractors in CPWD (Horticulture), State Govt. or PSU or Autonomous body or having well settled nursery or should be specialized Florist having more than 5 years of experience in supply of cut flowers (ending with 31.03.2025). Certificate of incorporation/registration as proof of existence along with the completion certificate of similar works should be furnished along with the bid. The firm must be registered with any of the above mentioned departments or having supplied similar items prior to the year 2020.
- (ii) The bidder should have completed successfully and satisfactorily supplying of cut flowers during last 5 years **ending with 31.03.2025** (01.04.2020 to 31.03.2025). The said completion certificate orders should include the total cost as mentioned under for supply of cut flower to Government Ministries/ departments/ PSUs, 5 Star Hotels as per star classification by Ministry of Tourism, etc.
 - (a) Three similar contracts each costing not less than **Rs.37,50,000**
 - (b) Two similar contracts each costing not less than **Rs 50,00,000**/-.

 Or
 - One similar contracts each costing not less than Rs 1,00,00,000/-.

Proof duly supported by documentary evidence should be uploaded with the technical bid.

- (iii) The average annual turnover of the firm for the last **03 financial years** ending 31.03.2025 should not be less than **Rs 37 Lakh.** A certificate duly certified by Chartered Accountant should be uploaded with the technical bid.
- (iv) The Firm must have Goods and Service Tax (GST) Registration Number. A copy of the GST Registration Certificate should be uploaded with the Technical Bid.

(v) The bidder must upload scanned copy of PAN No. along with Income Tax Return for last 3 **financial years** ending with **31.03.2025** with technical bid.

Terms and Conditions

- 1. The Bidder shall quote their rates on quarterly basis in the provided BOQ1, BOQ2, BOQ3 & BOQ4 so as to allow for seasonal variations in rates without compromising the quality.
- 2. Unless otherwise specified in the Schedule of Quantity, the rates of all the items shall be considered as inclusive of all charges, taxes and transportation.
- 3. Tenderer has to furnish earnest money deposit of **Rs** 3,75,000/- (Rupees three lakh seventy five thousand only) in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any commercial bank drawn in favor of the Pay & Accounts Officer, President's Secretariat payable at New Delhi. The original EMD in the form of Demand Draft should be deposited at the Garden Section, President's Secretariat, Rashtrapati Bhavan, New Delhi within the period of bid submission failing which the bid submitted will not be considered.
- 4. EMD should reach the undersigned before the last date of bid submission, failing which offer will be liable for rejection. Bidders have to attach scanned copies of the Earnest Money Deposit along with e-bid.
- 5. The bid shall not be considered without earnest money in the form mentioned above.
- 6. The successful tenderer shall need to deposit a "Performance security" equivalent to 3% of the tendered cost in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from any commercial bank drawn in favour of Pay & Accounts Officer, President's Secretariat. The performance security will be returned after 60 days of obligations/completion of the work. The performance security shall be forfeited in case of the successful bidder refuse or fail to execute the order after the acceptance of tender. No interest shall be paid on Performance security.
- The Earnest Money deposit during the period of bid submission shall be returned to successful tenderer after receiving the aforesaid performance security.
- 8. The earnest money of unsuccessful tenders shall be returned after award of the tender. No claim will be entertained for any delay in this regard.
- 9. No interest on the Earnest Money Deposit as well as Performance security shall be paid.
- 10. The EMD will be forfeited in the following conditions:
 - (a) If at any stage, any of the information/declaration given by the bidder is found false;
 - (b) In case of any lapse/default with regard to the terms and conditions of the NIT at any stage after submitting the bid.

- (c) In case of final selection, if the bidder fails to furnish Security Deposit in accordance with the terms and conditions of the NIT.
- (d) if the bidder declared successful for the offer, does not accept the work for any reasons, whatsoever.
- 11. Conditional tender in any form will not be accepted.
- 12. The supply of cut flowers shall be given at South Basement Entrance/Security Gate of Rashtrapati Bhavan before 07.30 AM or as required by this Secretariat daily for the period of the contract.
- 13. The entry of vehicles/workers into the President's Estate is through temporary entry passes to be made by the Security Office of the Rashtrapati Bhavan for which the contractor shall submit the details in advance. Workers with good conduct records only would be allowed to work.
- 14. The Department shall not be responsible for any injury partial or permanent or death of any worker at site due to accident or malfunctioning of the equipment or by negligence of the staff.
- 15. The flowers should be fresh, firm, healthy, disease free and as per specification given in schedule of quantity.
- 16. The rejected flowers should be replaced immediately by the contractor at his own risk and cost.
- 17. The demand for fresh cut flowers will be made as per actual requirements of the President's Gardens, President's Secretariat. Moreover, the quantity mentioned in the BoQ is a likely drawl and there is no commitment towards drawl on these quantities.
- The Fresh Cut Flowers should be provided in multi-color as per our requirement.
- 19. In the event of emergency, the supply of cut flowers should be made available at short notice.
- 20. The quality and freshness of cut flowers supplied shall be ensured and maintained by the contractor.
- 21. For any irregularity and interrupted supply of cut flower a fine 0.5% (half percent) of the contract value shall be imposed/deducted in the bills of the supplier. The penalty on this account shall however be limited to a maximum 5% (five percent) of the contract value during whole contract period.
- 22. Failure to supply on time will also attract deduction of expenditure occurred in procurement of supply from market for that day from the Contractor's bill.
- 23. Short supply/ non-supply of cut flowers in emergency, the requirement will be fulfilled from other firms/ open market upto Rs. 2 Lakh and cost to be borne by the Firm.
- 24. Repeated occurrence of the same will entail appropriate action as per Manual of Procurement of Goods/General Conditions Contract.

- 25. If there is repeated deviation from scheduled delivery, the contract shall be terminated.
- 26. If any damage caused to public convenience/services, the same shall have to be repaired instant, failing which necessary recovery shall be made from the contractor's bill.
- 27. The contractor has to work in restricted area and in restricted time due to security reason. He shall be bound by the instructions of security staff and Officer-in-charge in this respect.
- 28. I accept all the terms and conditions as laid down above.

Instruction to the Contractors/Bidders for the e-submission of the bids on the Central Public Procurement Portal [e-procurement].

- 1) Possession of valid Digital Signature Certificate (DSC) and enrollment/registration of the contractors/bidders on the procurement/e-tender portal is a prerequisite for e-tendering.
- 2) Bidder should do the enrollment in the e-Procurement site using the "Click here to Enroll" option available on the home page. Portal enrollment is generally free of charge. During enrollment/registration, the bidders should provide the correct/true information including valid email id. All the correspondence shall be made directly with the contractors/bidders through email id provided.
- 3) Bidder need to login to the site thro' their user ID/password chosen during enrollment/registration.
- 4) Then the Digital Signature Certificated (Class II or Class III Certificate with signing key usage) issued by SIFY/TCS/nCode/eMudra or any Certifying Authority recognized by CCA India on eToken/Smart Card, should be registered
- 5) The DSC that is registered only, should be used by the bidder and should ensure safety of the same.
